In Witness Whereof the said vendor has executed this Memorandum June 20, 2001.

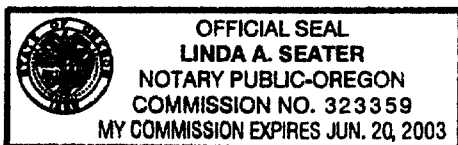
