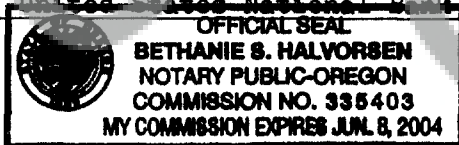

together with the debt thereby secured, is fully paid, satisfied, and discharged.


