KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Bill W. Barnes & Janet M. Barnes, as Tenants by the Entirety, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 45, Block 6, Tract No. 1017 Mountain Lakes Homesites situated in Section 17, Township 36 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon.
