## STATUTORY WARRANTY DEED

Lot 7 in Block 8 Tract No. 1069, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

This property is free of liens and encumbrances, EXCEPT:

Reservations and restrictions in the dedication of Tract No. 1069, as follows: "...)25 foot building set-back from front and side property lines.2)Public utilities easements 16 feet in width centered on all side and back lot lines.3)One foot reserve strips (street plugs) as shown on the annexed plat to be dedicated to Klamath County and later released by resolution of the County Commissioners when the adjoining property is properly developed.4)All sanitary facilities released subject to approval of the county sanitarian.5)Upper 35 feet from the high water mark, the mean thereof, of the Little Deschutes River is reserved for public access easement.6)Public access to the Little Deschutes River is provided by easements 10 feet in width as shown on the annexed plat.7)All existing easements and reservations of record.8) A sanitary line set-back 100 feet from the flood plane of the Little Deschutes River as shown on the annexed plat."
