MODIFICATION OF DEED OF TRUST

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Decrease Interest Rate by .50%, from South Valley Bank & Trust Prime plus 2.00% to Prime plus 1.50%. Extend Maturity Date to July 30, 2002.
