

AMENDMENT TO DECLARATION OF CONDITIONS AND RESTRICTIONS
MIDLAND HILLS ESTATES

WHEREAS, a Declaration of Conditions and Restrictions, Midland Hills Estates was recorded in volume M70, Page 3339 of the Deed of Records of Klamath County, Oregon on April 29, 1970; and

WHEREAS, the Declaration provides that it can be amended by a majority of lot owners, and

WHEREAS, Midland Hills Estates consists of thirty-four (34) lots; and

WHEREAS, a majority of the current owners of the lots of Midland Hills Estates have agreed to amend the covenants as provided hereinbelow as indicated by their signatures subscribed hereto, and

WHEREAS, the Declarations prohibit the keeping of animals for commercial purposes.

NOW, THEREFORE, the Declarations of Conditions and Restrictions, Midland Hills Estates are hereby amended as follows:

That sentence on Page 2 of the Declaration, which reads "Dogs, cats and other household pets may be kept provided they are not kept, bred or maintained for commercial purposes" is hereby deleted.

WHEREFORE, a majority of the current owners of lots of Midland Hills Estates have agreed to the above amendment.
