MEMORANDUM OF LAND SALE AGREEMENT

**KNOW ALL MEN BY THESE PRESENTS**, that on August 7, 2001, **Klamath County**, a Political subdivision of the State of Oregon, as vendor and Chip Sweeney, as vendee(s) made and entered into a certain Land Sale Agreement wherein said vendor agree to sell to said vendee(s) and the latter agreed to purchase from said vendor the fee simple title in and to the following described real property in Klamath County, State of Oregon, to-wit:

A portion of Government Lot 19, being a portion of the NE¼ SW¼ of Section 9, Township 36 South, Range 11 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at the Southeast corner of Lot 6, Nimrod River Park; thence S 1° 04' E to a point on the North boundary of Government Lot 19 for the true point of beginning; thence S 1° 04' E to a point on the Northerly bank of the Sprague River; thence in a Northwesterly direction along the Northerly bank of said river to a point, which bears S 1° 04' E from the Southwest corner of Lot 6; thence N 1° 04' W to the North boundary of Government Lot 19; thence S 89° 49' 30" E along said boundary to the point of beginning.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$1,680.00, all deferred payments bear interest at the rate of 9% per annum from the date of said Land Sale Agreement until paid.

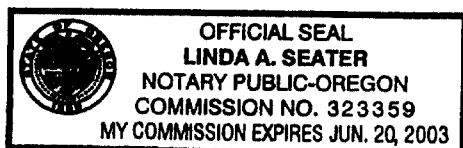
