MEMORANDUM OF LAND SALE AGREEMENT

The S½ SE¼ NW¼ SW¼ of Section 21, Township 34 South, Range 13 East of the Willamette Meridian, Klamath County, Oregon.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$2,002.00, all deferred payments bear interest at the rate of 10% per annum from the date of said Land Sale Agreement until paid.

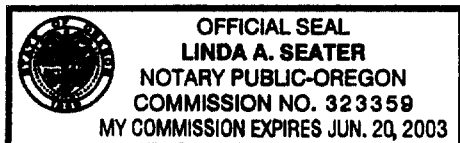
