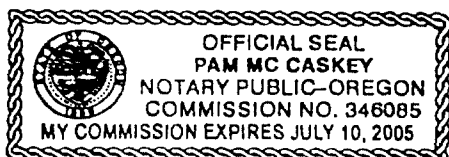

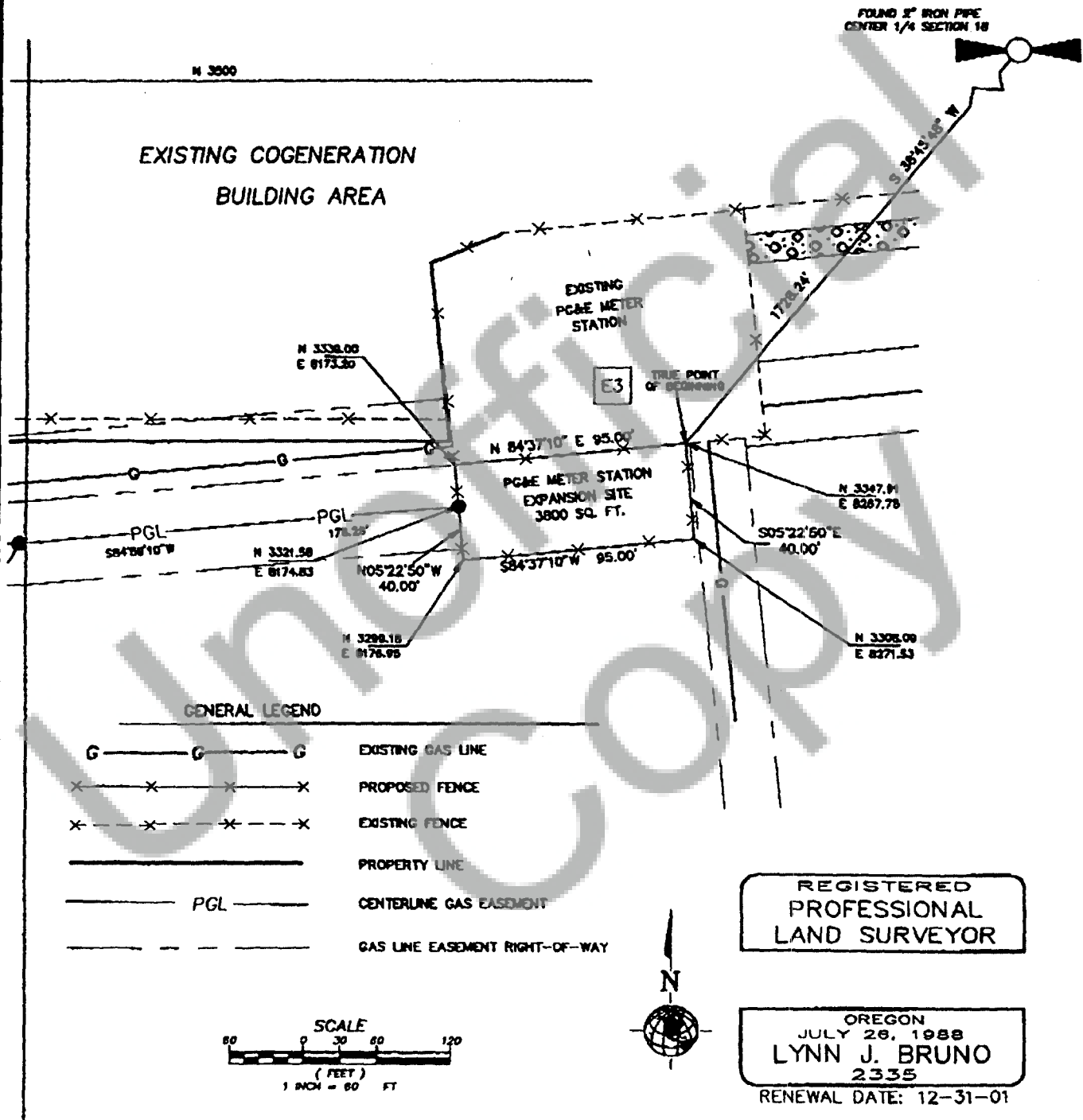

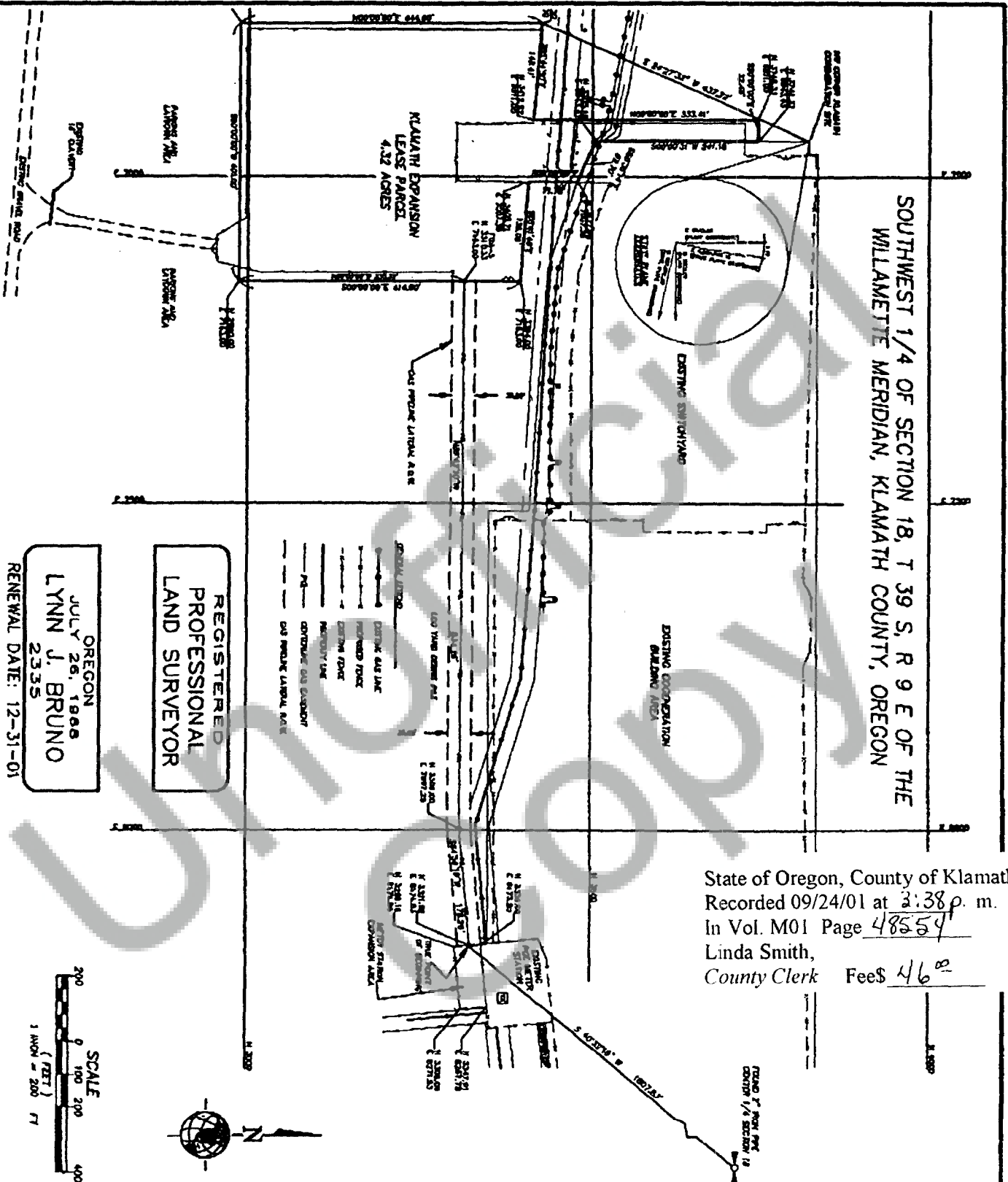
AN EASEMENT 35 FEET WIDE OVER AND ACROSS THE SOUTHWEST ONE-QUARTER OF SECTION 18, TOWNSHIP 39 SOUTH, RANGE 9 EAST OF THE WILLAMETTE MERIDIAN, KLAMATH COUNTY, OREGON. THE BOUNDARIES OF SAID EASEMENT LIE 17.50 FEET EACH SIDE OF, AND PARALLEL WITH THE CENTERLINE AND ARE TO BE EXTENDED OR SHORTENED TO TERMINATE AT THE PG&E METER STATION ON THE EAST END AND AT THE KLAMATH EXPANSION LEASE PARCEL ON THE WEST END. THE CENTERLINE IS DESCRIBED WITH REFERENCE TO THE KLAMATH COGENERATION PLANT COORDINATE SYSTEM WHICH IS ROTATED 2°46'12" FROM THE OREGON STATE PLANE COORDINATE SYSTEM, SOUTH ZONE (NAD83/91), SAID CENTERLINE BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE CENTER ONE-QUARTER OF SAID SECTION 18, EVIDENCED BY A 2" IRON PIPE; THENCE SOUTH 40°32'18" WEST, 1807.83 TO A POINT ON THE WESTERLY BOUNDARY OF THE PG&E METER STATION EXPANSION SITE AND THE TRUE POINT OF BEGINNING; THENCE LEAVING SAID WESTERLY BOUNDARY SOUTH 84°59'10" WEST, 178.26 FEET; THENCE NORTH 89°42'10" WEST, 834.26 FEET TO A POINT ON THE EAST BOUNDARY OF THE KLAMATH EXPANSION LEASE PARCEL, SAID POINT BEARS NORTH 00°00'00" WEST, 330.33 FEET FROM THE SOUTHEAST CORNER OF SAID PARCEL AND IS THE TERMINUS OF THIS EASEMENT.
