TERMINATION DECLARATION DECLARATION OF VACATION OWNERSHIP PROGRAM (EAGLE CREST VACATION CLUB – RUNNING Y RANCH RESORT AND PELICAN SPRINGS CHALETS AT RUNNING Y RANCH RESORT)

THIS TERMINATION DECLARATION made this 3/57 day of August, 2001, by EAGLE CREST, INC., an Oregon corporation, doing business as Eagle Crest Communities, ("Declarant") and THE EAGLE CREST VACATION CLUB, an Oregon nonprofit mutual benefit corporation, ("Co-Declarant") is as follows:

RECITALS

- A. Declarant is the Declarant and Co-Declarant is the Co-Declarant under that certain Declaration of Vacation Ownership Program recorded March 2, 1999 in Volume M99 at Page 7309; and that certain Declaration of Vacation Ownership Program recorded March 30, 1999 in Volume M99 at Page 11181, Microfilm Records of Klamath County, Oregon (hereinafter referred to as the "Declaration"). Each of the definitions contained in the Declaration are hereby adopted by reference.
- B. By Declaration of Annexation recorded March 30, 1999 in Volume M99 at Page 11214, Microfilm Records of Klamath County, Oregon, Declarant caused certain additional property (the "Additional Property") to be annexed to the Declaration of Vacation Ownership Program recorded March 30, 1999 in Volume M99 at Page 11181.
- C. Declarant has the right pursuant to Article 10, Section 10.1 of the Declaration, to terminate the Declaration upon the affirmative vote of a majority of the Voting Power residing in Members other than Declarant. The Members have approved said termination in favor of a merger of The Eagle Crest Vacation Club Program with Worldmark, The Club Program as provided in the Merger and Acquisition Agreement dated May 4, 2001between Declarant, Co-Declarant, Trendwest Resorts, Inc., an Oregon corporation, and WorldMark, The Club, a California nonprofit mutual benefit corporation.

NOW, THEREFORE, in furtherance of such intent, Declarant and Co-Declarant hereby declare that the Declaration is hereby terminated and the Property and Additional Property described in Exhibit "A" attached hereto shall be free from all terms, covenants, conditions and restrictions of said Declaration.
