In reference to the Declaration of Conditions and Restrictions pertaining to Tract 1203-Country Village, filed with the County Clerks Office Under Volume M 83 Pages 3079, 3080 and 3081, dated the 18<sup>th</sup> day of 1982, the following amendment is to be recorded.

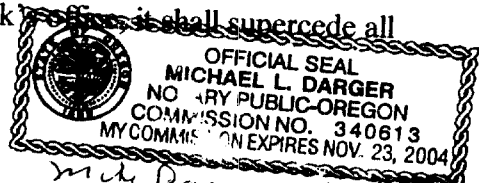
On the 18<sup>th</sup> day of October, a meeting was held and attended by a majority of the home owners within tract 1203, Country Village. This meeting was to discuss issues involving the current Board, consisting of William Gardiner, Darrell Sales and Hazel Toney, and the Declaration of Conditions and Restrictions.

As outlined in the Declaration of Conditions and Restricts, Section C, Item 1, "Any Trustee may be removed from the Board for any reason by a majority vote of the Trustees." The following changes were decided: William Gardiner and Darrell Sales were removed from the board and Hazel Toney was retained as a current Board Member. This decision was conducted by a secret ballot, by those attending the above mentioned meeting.

As a result of the above action, two vacancies existed on the Board. A motion was made and seconded to fill the vacancies immediately. Kim Mangold, Kelly Howland and Ed Mitchell nominated themselves for those positions. A secret ballot vote was conducted. As a result and by a mojority vote, the Board shall consist of the following trustees: Hazel Toney, Kelly Howland and Kim Mangold.

By filing this document with the Klamath County Clerk's Office, it shall supercede all previously submitted Amendments.

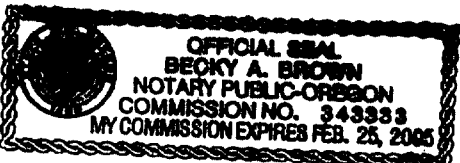
