STATUTORY WARRANTY DEED

John B. McColgin and Eleanor A. McColgin, as tenants by the entirety as to Parcel 1 and Parcel 2, Grantor, conveys and warrants to <u>Heidi Lyn Neel</u>, Grantee, the following described real property free of liens and encumbrances, except as specifically set forth herein:

PARCEL 1:

A tract of land described as follows: Beginning at an iron pin on the Westerly right of way line of the Secondary Highway No. 421 in Section 23, Township 38 S., R 8 E.W.M., which iron pin is also the most Northerly corner of Lot 24 of Lakewood Heights, and running thence S. 64 degrees 35'W a distance of 157.7 feet to an iron pin which marks the most Westerly corner of said Lot 24; thence S. 35 degrees 38'E, a distance of 32.5 feet to an iron pin; thence S. 53 degrees 06'E, a distance of 45.0 feet to an iron pin; thence N. 60 degrees 01'E. a distance of 136.8 feet to an iron pin on the Westerly right of way line of Secondary Highway No. 421; thence in a Northwesterly direction following the Westerly right of way line of Secondary Highway No. 421 along a 7 degree 40' curve to the right a distance of 60 feet, more or less, to the point of beginning, said tract being a portion of Lot 24 of LAKEWOOD HEIGHTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
