KNOW ALL MEN BY THESE PRESENTS, That Michael B. Jager and Margaret H. Jager, Trustees of the Jager Family Trust, dated 10-15-91, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Daniel & Maddy Darrow as to an undivided 1/2 interest, and Albert Carleton Elliott, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

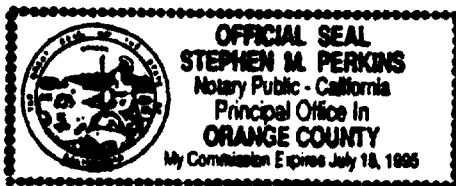
