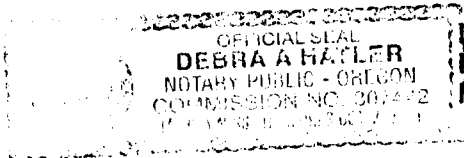

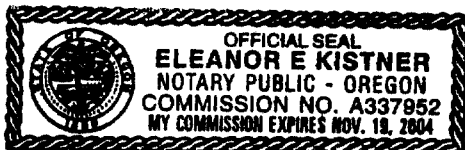
DEED OF FULL RECONVEYANCE
