- 4) Surrender the Manufacturer's Certificate of Origin (MCO) or Out-of-State Title to DMV;
- 5) Mail to: DMV Title Exemption Desk, 1905 LANA AVE NE, Salem, Oregon 97314; and
- 6) Furnish a copy to the county tax collector.




EXHIBIT 'A'
