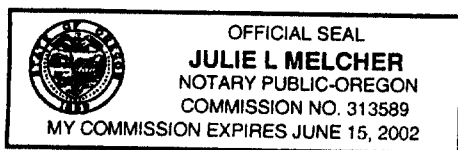

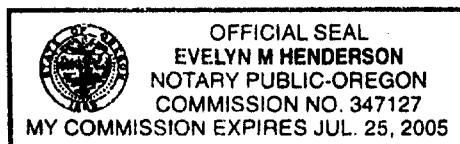

## EXHIBIT "A"

A parcel of land situated in the SW  $\frac{1}{4}$  of Section 25, Township 24 South, Range 8 East of the Willamette Meridian, in the County of Klamath, State of Oregon, being more particularly described as follows:

Beginning at a  $\frac{5}{8}$  inch iron pin marking the northeast corner SE  $\frac{1}{4}$  SW  $\frac{1}{4}$  of said Section 25; thence South along the East line of said SE  $\frac{1}{4}$  SW  $\frac{1}{4}$  Section 25, 78.77 feet; thence South  $62^{\circ}49'$  West, 576.08 feet; thence North 334.91 feet to a point on the North line of said SE  $\frac{1}{4}$  SW  $\frac{1}{4}$  Section 25; thence North  $89^{\circ}12'47''$  East along said North line, 512.5 feet to the point of beginning.
