## TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT, dated this 2672 day of Levenber, 2001, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Gilchrist Timber Company granted to the United States of America an easement for a fence, known as the Antelope Boundary Fence Project Number 7022 dated November 14,1963, and recorded on November 27, 1963, in Book 349, at page 424, County of Klamath, State of Oregon, over and across the following described premises:

"A strip of land 12 feet in width, traversing the following described property: Beginning at the Southeast corner of section 24, T. 26 S., R. 10 E., W.M., surveyed, thence approximately 32 chains North along the East section line of said section and ending at the South edge of Road #265C, encompassing an area of 0.58 acres, more or less."

which easement contained the following provisions:

".... The rights, priviledges and authorities herein granted shall continue as long as used for the purposes granted, but, if for a period of five years the Grantee shall cease to use the rights, privileges and authorities for the purposes granted or shall abandon the use of the easement herein granted, then, in any such events, the premises traversed thereby shall be freed from said easement as fully and completely as if this indenture had not been made."

and

WHEREAS, the undersigned has determined that the United States of America has no further need for said easement.

NOW THEREFORE, this TERMINATION OF EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no further need for the easement and that the easement pursuant to its provisions has ceased and terminated and is hereby cancelled.

Now, therefore, THE United States of America, by the Forest Supervisor, Fremont and Winema National Forests, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.


