TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT, dated this 26th day of November, 2001, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Gilchrist Timber Company granted to the United States of America an easement for Road No. 2653 and 2653K, dated June 6, 1977, and recorded on June 14, 1977, as Instrument No. 30971 in Book M77, at page 10348, County of Klamath, State of Oregon, over and across the following described premises:

T. 26 S., R. 10 E., W.M.
Sec. 25, NW1/4SW1/4 and SW1/4NW1/4

T. 27 S., R. 10 E., W.M.
Sec. 2, S1/2NE1/4 and NE1/4SE1/4
Sec. 3, E1/2SE1/4

which easement contained the following provisions:

"This grant shall continue as long as needed for the above purposes, and shall expire upon the completion of the above work, or July 1, 1982, or upon the exchange of easements through the proposed Winema National Forest-Gilchrist Timber Company Road Management and Maintenance Agreement, whichever occurs first."

and

WHEREAS, the undersigned has determined that the United States of America has no further need for said easement.

NOW THEREFORE, this TERMINATION OF EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no further need for the easement and that the easement pursuant to its provisions has ceased and terminated and is hereby cancelled.

Now, therefore, THE United States of America, by the Forest Supervisor, Fremont and Winema National Forests, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.

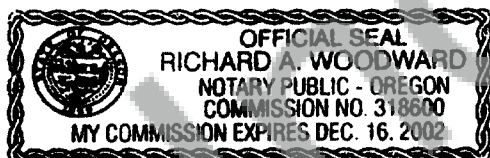
