## DEED IN LIEU OF FORECLOSURE

LINDA K. NEILL, Grantor, for and in consideration of the covenants contained herein and the release from certain personal indebtedness arising from a trust deed dated November 19, 1997, in the amount of \$25,000, recorded at Volume M97, page 39650, Microfilm Records of Klamath County, Oregon, of which 24,658.83 in principal is unpaid as of April 19, 2001, with interest thereon, hereby assigns, transfers, sets over, and conveys to ROBERT J. MULLEN and LAURA J. MULLEN, Trustees of the MULLEN FAMILY TRUST DATED JULY 5, 1995, Grantee, all the Grantor's right, title, and interest in and to the following described real property situated in Klamath County, Oregon:

Lot 2 in Block 6 of BELLA VISTA, TRACT NO. 1235, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Grantor covenants that:

This deed is an absolute conveyance in effect as well as in form and conveys fee simple title of the premises above described to the Grantee and does not operate as a mortgage, trust conveyance or security of any kind, and is not now or ever intended as a mortgage, trust conveyance or security of any kind.

Grantor is the owner of the premises, free of all encumbrances, excepting only those encumbrances of record.

This deed does not affect a merger of the fee ownership and the lien of the trust deed described above. The fee and lien shall hereafter remain separate and distinct, and the Grantee shall not be prohibited from proceeding to foreclose the lien or pursue other remedies of the trust deed described above to clear title.

By acceptance of this deed, Grantee covenants and agrees that they shall forever forbear taking any action whatsoever to collection against the Grantor on the trust deed above described, other than by foreclosure or trustee's power of sale of that trust deed and that in any proceeding pursuant to the trust deed remedies, it shall not seek, obtain or permit a deficiency judgment against the Grantor, or the Grantor's successors or assigns, such rights and remedies being waived. Grantee expressly reserves its rights and remedies in all other proceedings and suits now filed or pending or to be filed, if any, either in equity or at law.

The Grantor does hereby waive, surrender, convey and relinquish any equity of redemption concerning the real property and trust deed described above.

The Grantor is not acting under any misapprehension as to the legal effect of this deed, nor under any duress, undue influence, or misrepresentation of Grantee, the Grantee's agents or attorneys, or any other person.

The Grantor agrees that Grantee shall retain all payments made on the contract by the Grantor. The Grantee does not assume any responsibility for any liabilities incurred by Grantor or by any other person.

This Deed is made by the Grantor as a result of the Grantor's own request and as the Grantor's free and voluntary act.

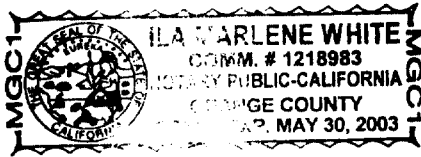
