APPOINTMENT




RECONVEYANCE

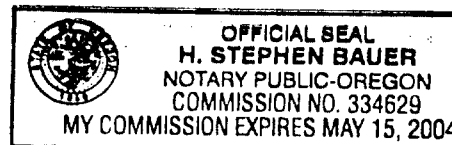


