EXHIBIT "A"
LEGAL DESCRIPTION

Lots 1 and 2 in Block 54, BUENA VISTA ADDITION TO THE CITY OF KLAMATH FALLS, EXCEPTING THEREFROM that portion conveyed to the State of Oregon, by and through its State Highway Commission, recorded August 8, 1958 in Deed Volume 302 at page 14, Deed Records of Klamath County, Oregon.

ALSO that portion of Lot 3 in Block 54, BUENA VISTA ADDITION to the City of Klamath Falls, Oregon, more particularly described as follows:

Beginning at a point on the Southeasterly line of said Lot 3, 10 feet Southwesterly from the Northeast corner thereof; thence along said Southeasterly line 20 feet to a point; thence Northwesterly to a point, said point being 20 feet from, when measured at right angles to the point of beginning; thence Southeasterly to the point of beginning.
