THIS TERMINATION OF EASEMENT, dated this 4th day of February, 2002, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Gilchrist Timber Company granted to the United States of America an easement for Mowich Springs Road No.2516, dated February 11, 1966, and recorded on February 18, 1966, in Book M 66, at page 1385, County of Klamath, State of Oregon, over and across the following described premises:

T. 25 S., R. 11 E. W.M.
Sec. 14, SW1/4SW1/4
Sec. 15, SE1/4SE1/4

which easement contained the following provisions:

"Provided, however, that if for a period of five years the Grantee shall cease to use the road, or parts thereof, for the purposes granted, or shall abandon the same, then, in any events, the premises traversed thereby shall be freed from said easement, or parts thereof, as fully and completely as if this deed had not been made. In the event of such non-use for the period stated, the Regional Forester shall furnish to the Grantor a statement in recordable form evidencing such non-use."



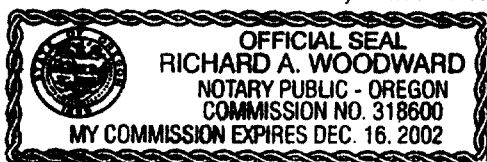
