THIS TERMINATION OF EASEMENT, dated this 4th day of February, 2002, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Gilchrist Timber Company granted to the United States of America an easement for Road No. 2451L (9775720), 2423 (9775770), 2422 (9775900) dated October 23, 1978, as Instrument No. 58046 and recorded on November 8, 1978, in Book M 78, at page 25159, County of Klamath, State of Oregon, over and across the following described premises:

T. 24 S., R. 10 E. W.M.
Sec. 36, E1/2E1/2

T. 24 S., R. 11 E., W.M.
Sec. 31, lots 8, 20, NE1/4SE1/4

which easement contained the following provisions:

"If for a period of five (5) years, the Grantee shall cease to use, or preserve for prospective future use, the road, or segments thereof for the purposes granted, or if at any time the Regional Forester determines that the road, or any segment thereof, is no longer needed for the purposes granted, the easement traversed thereby shall terminate. In the event of such non-use or of such determination by the Regional Forester, the Regional Forester shall furnish to the Grantor, its successors, or assigns a statement in recordable form evidencing termination."

and

WHEREAS, the undersigned has determined that the United States of America has no further need for said easement.

NOW THEREFORE, this TERMINATION OF EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no further need for the easement and that the easement pursuant to its provisions has ceased and terminated and is hereby cancelled.

IN WITNESS WHEREOF, the United States of America, by the Forest Supervisor, Fremont and Winema National Forests, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement..

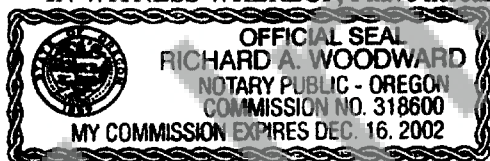


