EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land called 3A (See Record of Survey #1010), located in the Southwest corner of W1/2 NE1/4 SW1/4 of Section 9, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a 1/2 inch iron pin located South 0 degrees 21' West, 898.34 feet from the center West 1/16 corner of Section 9; thence South 89 degrees 34' East, 328.50 feet to a point; thence South 0 degrees 16 1/2' West 447.86 feet to a point; thence North 89 degrees 48' West, 329.17 feet to a 1/2 inch iron pin Southwest 1/16 corner Section 9; thence North 0 degrees 21' East, 449.17 feet to the point of beginning.
