TERMINATION OF EASEMENT

WHEREAS, on December 30, 1975 the United States of America, acting by and through the Forest Service, Department of Agriculture as Grantor, executed an easement for roads across certain land in Klamath and Lake Counties, Oregon, to Gilchrist Timber Company as Grantee, which deed is recorded in the public records of Klamath County, Oregon, in Book M-76 at page 3464, and recorded in the public records of Lake County, Oregon in Vol. 170 at page 488 reference to said easement and the record thereof is hereby made for a more complete description of said easement and the terms thereof; and

WHEREAS, for good and valuable consideration, Crown Pacific Limited Partnership, successor in interest to Gilchrist Timber Company Grantee, by joining in the execution of this document, consents to the termination of a portion of said easement described in Exhibit A attached hereto; and

WHEREAS, said easement provided that the Chief, Forest Service, may terminate the easement or any portion thereof by consent of the Grantee;

NOW THEREFORE, the United States of America, by the Forest Supervisor, Fremont and Winema National Forests, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.

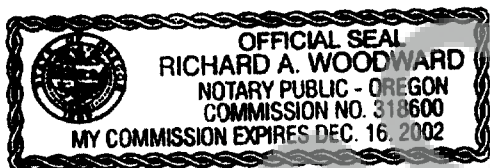
