EXHIBIT "A" DESCRIPTION OF PROPERTY

PARCEL ONE:

Lots 1, 2, 3, 11, 12, 13 and 16, and the W ½ of Lot 15 of the Resubdivision of Block 1 of CANAL ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, SAVING AND EXCEPTING therefrom that portion of said Lot 3, described as follows: Beginning at the corner common to Lots 3, 4 and 5; thence Southeasterly on the line extended between Lots 4 and 5 a distance of 32.93 feet to street; thence Southwesterly along Northwest line of street 12.42 feet to the Southerly corner of Lot 3; thence Northwesterly along line between Lots 3 and 5 a distance of 16.69 feet; thence North 20.42 feet to the point of beginning.
