This deed, made this 2nd day of December, 1998, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a political subdivision of the State of Oregon, "Grantee".

WITNESSETH

WHEREAS, pursuant to a Judgment Decree and Order of the Circuit Court of the State of Oregon, in and for the County of Klamath, duly made and entered on the 28th day of February, 1996, in a suit wherein the said Klamath County, Oregon, was Plaintiff and Frank J and Dorothy M Aerts, et al were Defendants, the hereinafter-described real properties were, by said Judgment Decree and Order, sold subject to redemption to Klamath County, Oregon; and

WHEREAS, the said real properties have been held by said Klamath County, Oregon, for a period of two (2) years from and after the date of said Judgment and Decree of Foreclosure, and no redemption has been made, and notice of expiration of redemption period has been given in the duly designated newspaper of general circulation and published in Klamath County, Oregon, to wit, the HERALD & NEWS, in two (2) weekly issues of said newspaper, not more than 30 days and not less than 10 days, prior to the date of expiration of the redemption period, proof of which notice is attached hereto as Exhibit "A", and by this reference make a part hereof; and

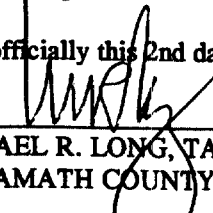

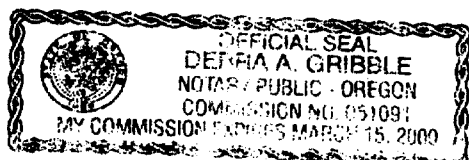
