WHEREAS, pursuant to a Judgment Decree and Order of the Circuit Court of the State of Oregon, in and for the County of Klamath, duly made and entered on the ~~22nd day of December, 1993~~, in a suit wherein the said Klamath County, Oregon, was Plaintiff and Anthony Land & Livestock, et al were Defendants, the hereinafter-described real properties were, by said Judgment Decree and Order, sold subject to redemption to Klamath County, Oregon; and


