COMMUNICATIONS LINE RIGHT-OF-WAY EASEMENT

DBA CENTURYTEL, its successors and assigns, (hereinafter referred to as the Company), the right to bury and maintain underground telephone and communications facilities, together with all necessary wires and fixtures incidental thereto, under and upon the following described property:

Lot 14, Block 1, TRACT 1118, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, said described property being situated in the SW¼ Section 25, T.34S., R.8E., W.M. Said facilities to be placed along and adjacent to that roadway commonly known as 9 Mile Road, as it exists, located along and adjacent to the Northerly and Westerly boundaries of said described property.

situated in the County of Klamath, State of Oregon. It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction. Said property shall be restored, as nearly as reasonably possible, to prior or better condition in a workmanlike manner.

Nothing in this grant of easement shall be construed, in any way, so as to represent a warranty or representation by the undersigned grantor with regard to any property lines bounding the above described property, or the location or the validity of any other easements.

It is the intent of this easement grant that the Company shall place all facilities authorized hereunder as close as is reasonably practical to the existing fence line situated West and North of and running generally parallel to the aforesaid Nine Mile Road.

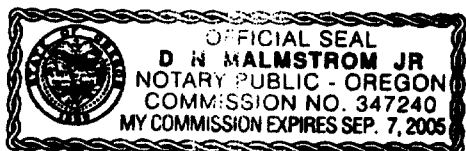
