TERMINATION DECLARATION OF LOTS 792 - 795 AND LOTS 818 - 820 OF PHASE 1 OF VIEW POINT HOMESITES AT **RUNNING Y RANCH RESORT**

THIS TERMINATION DECLARATION made this 12th day of MWW. 2002, by RUNNING Y RESORT, INC., an Oregon corporation, ("Declarant") and MARK N. WAYNE AND MARION L. PODESTA is as follows:

RECITALS

- A. Running Y Ranch Resort consists of certain real property ("Property") located in the County of Klamath, State of Oregon. The "Property", known as Running Y Ranch Resort, within Klamath County, Oregon, is subject to that certain Declaration of Protective Covenants, Conditions, Restrictions and Easements for Running Y Ranch Resort, dated August 2, 1996, and recorded August 2, 1996, in Volume M96, Page 23548, Official Records of Klamath County Recorder (hereinafter referred to as the "Declaration"). Each of the definitions contained in the Declaration are hereby adopted by reference.
- B. By Declaration of Annexation dated September 28, 2001 and recorded October 1, 2001 in Volume M01, Page 50048, Official Records of Klamath County Recorder, Declarant caused certain Additional Property ("Annexed Property") described in Exhibit A attached hereto and made a part hereof to be annexed to the Declaration and to Phase 1 of the Project known as View Point Homesites (the "Project").
- C. Declarant has the right pursuant to Article 2, Section 2.4 of the Declaration, to cause the Annexed Property to be withdrawn if the withdrawal is for the purpose of making adjustments to boundary lines which do not result in a reduction in the total number of Living Units.
- D. Declarant has conveyed Lot 795 within the Annexed Property to Mark W. Wayne and Marion L. Podesta and Mark W. Wayne and Marion L. Podesta consent to the withdrawal of Lot 795 from the Property and the Project. By this Termination Declaration, Declarant and Mark W. Wayne and Marion L. Podesta intend to withdraw Lots 792, 793, 794, 795, 818, 819, 820 from Running Y Ranch Resort and the Declaration for the purposes of making adjustments to boundary lines.
- NOW, THEREFORE, in furtherance of such intent, Declarant hereby declares that the Annexed Property shall be removed and withdrawn from the Declaration and the Project, and shall be free from the obligations, requirements, declarations, limitations, covenants, conditions and restrictions set forth in the Declaration and the Association Policies and Procedures. The Annexed Property contains seven (7) Lots.
