WHEREAS, on September 27, 2001, a letter mailed regular and certified mail requested the amount of \$502.42 for the August 15, 2001, annual installment be paid by October 30, 2001. A partial payment in the amount of \$200.00 was received and applied to the installment; and

WHEREAS, on February 26, 2002, a final notice mailed regular and certified mail requested the balance, interest and recording fee in the amount of \$758.63 be paid by March 5, 2002. A return receipt to Klamath County Property Sales was received on February 14, 2002; and

WHEREAS, no payment has been received the Land Sale Agreement is now in **Default**.

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Land Sale Agreement between Klamath County and Clinton Rajnus dated August 15, 2000, is hereby cancelled. NOTE: Pursuant to ORS 275.220 (2) within twenty (20) days after the service of the order of cancellation upon the holder, the holder of the canceled contract may appeal from such order to the circuit court for the county in which the land is located. The appeal shall be tried by the court as an action not triable by right to a jury. If appeal is not so taken or if it results upon trial in an affirmance of the order of cancellation, such order shall become absolute and the real property so forfeited again may be sold, without notice.
