**RE-ASSIGNMENT OF COLLATERAL ASSIGNMENT OF

A parcel of land in the NW 1/4 of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows: Starting at the Northwest corner of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Oregon, and running thence South 00 degrees 00 1/2' East along the Westerly boundary of Section 3, 977.8 feet, more or less, to its intersection with a line parallel with and 50 feet distant at right angles Southwesterly from the center line of the Dalles-California State Highway, also known as South Sixth Street as the same is now located and constructed; thence South 55 degrees 52 1/2' East along said parallel line 2322.07 feet; thence at right angles to South Sixth Street South 34 degrees 07 1/2' West 58 feet to Point F, the true beginning point of this description from which a cross chiseled in the sidewalk bears North 34 degrees 07 1/2' East 70 feet; thence North 55 degrees 52 1/2' West 61 feet to Point G, from which a cross chiseled in the sidewalk bears North 34 degrees 07 1/2' East 70 feet; thence South 34 degrees 07 1/2' West 119.61 feet to Point H; thence South 66 degrees 57 1/2' East 62.15 feet to Point E; thence North 34 degrees 07 1/2' East 107.65 feet to the point of beginning
