DEED OF RECONVEYANCE

FIRST AMERICAN TITLE INSURANCE COMPANY OF OREGON, an assumed business of Title Insurance Company of Oregon, hereinafter Trustee, under that certain Trust Deed dated June 12, 2000, executed and delivered by David Sutton, as grantor, recorded on June 20, 2000, in the Mortgage Records of Klamath County, Oregon in Volume M00 at page 22439, conveying real property situated in said county described as follows:

A tract of land situated in the NE ¼ SE ¼ of Section 6, Township 35 South, Range 9 E.W.M., Klamath County, Oregon, being more particularly described as follows:

Beginning at a 5/8 inch iron pin with Tru-Line Surveying, Inc., plastic cap, said point being on the Easterly edge of an access road, from which the C-E 1/16 corner of said Section 6 bears N. 30°10'19" W. 700.18 feet; thence S. 44°25'56" E. 355.8 feet, more or less, to the high water line of Sprague River; thence Southwesterly, along the said high water line, 297.2 feet, more or less, to the South line of the S ½ N ½ S ½ NE ¼ SE ¼ of said Section 6; thence N. 89°59'54" W., along the said South line, 131.0 feet, more or less, to a ½ inch iron pin on the Easterly edge of the access road; thence, along the said Easterly edge of the access road, N. 27°01'30" E. 279.42 feet and N. 08°33'44" E. 138.01 feet to the point of beginning, with bearings based on record of survey 3842 on file at the office of the Klamath County Surveyor.

Having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.

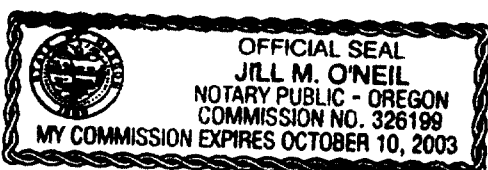
