

RESOLUTION NO. 02-16

A RESOLUTION INITIATING VACATION PROCEEDINGS FOR A
PORTION OF THE ARROWHEAD DRIVE RIGHT-OF-WAY
ADJACENT TO LOTS 1 THROUGH 4, BLOCK 3 OF THE
LYNNEWOOD, TRACT 1091 SUBDIVISION

WHEREAS, there has been submitted to the City of Klamath Falls a request for the Council to initiate vacation proceedings for a portion of the Arrowhead Road right-of-way adjacent to lots 1 through 4 of block 3 in the Lynnewood, Tract 1091 subdivision within the City of Klamath Falls, which right of way is shown on the attached map, Exhibit A; and

WHEREAS, ORS 271.130 and City of Klamath Falls Code Section 13.015 authorizes the Council to initiate vacation proceedings on its own motion without an application or consent of abutting property owners; **NOW THEREFORE**

THE CITY OF KLAMATH FALLS RESOLVES AS FOLLOWS:

Section 1.

Council does hereby initiate vacation proceedings for a portion of the Arrowhead Road right-of-way adjacent to lots 1 through 4 of block 3 in the Lynnewood, Tract 1091 subdivision. The Planning Director is hereby directed to initiate the vacation process under Sections 13.005 to 13.055 of the Community Development Ordinance.

Section 2.

This Resolution shall become effective immediately upon enactment.
