The City, its successors or assigns, shall not be liable to Grantor for damage to the Property occurring incidental to the property use of this easement. Provided, however, in the event of damage to premises outside of and adjacent to the Property caused by the city, its successors and assigns, the party causing such damage shall repair same and place said premises in as good condition as they were immediately prior to such damage.
