In Witness Whereof the said vendor has executed this Memorandum May 15, 2002.

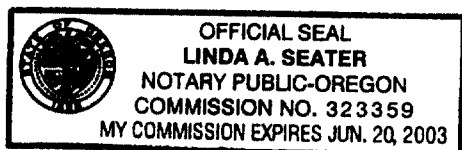
