

KNOW ALL MEN BY THESE PRESENTS, that on May 9, 2002, Klamath County, a Political subdivision of the State of Oregon, as vendor and Dana K. 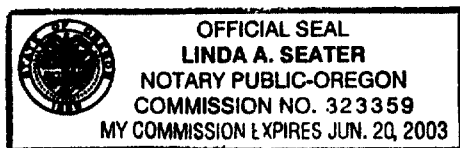
