
Lot 10, Block 10, Second Addition To Nimrod River Park, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

In Witness Whereof the said vendor has executed this Memorandum May 16, 2002.

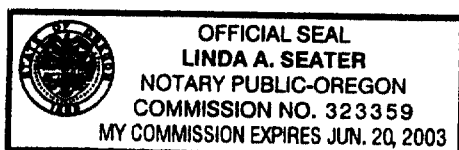


