EXHIBIT "A" LEGAL DESCRIPTION

A tract of land situated in Lots 5 and 6, Block 50, NICHOLS ADDITION TO THE CITY OF KLAMATH FALLS, in the County of Klamath, state of Oregon, more particularly described as follows:

Beginning at the most Westerly corner of Lot 5, Block 50, said Nichols Addition; thence Southeasterly along and parallel to the Northerly line of 10th Street 55 feet to the true point of beginning; thence continuing Southeast parallel with 10th Street 55 feet; thence Northeasterly parallel with Jefferson Street 100 feet; thence Northwesterly parallel with Jefferson Street 100 feet to the point of beginning.
