QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto City of Klamath Falls, a Municipal Corporation hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, Sate of Oregon, described as follows, to-wit:

Beginning at the Southwest corner of the NW¼ of the SW¼ of Section 32, Township 38 South, Range 9 East, Willamette Meridian, Klamath County, Oregon; thence East, along the South boundary of said NW¼ SW¼ to a point from which the most Southerly corner of Block 9, Riverside Addition to Klamath Falls bears N 21° E; thence N 21° E to the Southerly boundary of West Main Street (Bridge Street); thence S 66° W along the Southerly boundary of West Main Street to the West boundary of the NW¼ SW¼ of said Section 32; thence South along said West boundary to the point of beginning.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

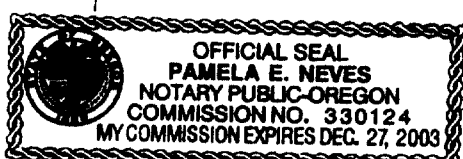
