Exhibit "A" Legal Description

Parcel 1 - Tax Lot 600

Beginning at the most Easterly corner of Lot 11, Block 13, HOT SPRINGS ADDITION to the city of Klamath Falls, Oregon; thence running Southwesterly along the Northwesterly line of Monclaire Street 53.1 feet; thence Northwesterly parallel with Alameda Street 88.0 feet, more or less, to the Northwesterly line of Lot 12 in said Block 13; thence Northeasterly along the Northwesterly line of Lot 12, 50.0 feet to the Southwesterly line of Alameda Street; thence Southeasterly along the Southwesterly line of Alameda Street 70.8 feet to the point of beginning, being a part of Lots 11 and 12 of said Block 13 of HOT SPRINGS ADDITION

Parcel 2 - Tax Lot 700

A Portion of Lots 11 and 12 of Block 13 of HOT SPRINGS ADDITION to the City of Klamath Falls, Oregon, more particularly described as follows: Beginning at a point 106.2 feet distant Southeasterly along the Northwesterly line of Monclaire Street from the most Easterly corner of Lot 11, Block 13 of said addition; thence in a Northwesterly direction parallel with the Southwesterly line of Alameda Street a distance of 106.7 feet, more or less, to an intersection with the Southeasterly line of Lot 13 in said Block 13; thence in a Northeasterly direction along the Southeasterly line of Lot 13, 50 feet; thence Southeasterly parallel with the Southwest line of Alameda Street 88 feet more or less to the Northwest line of Monclaire Street; thence Southwest along the Northwest line of Monclaire Street 53.1 feet more or less to the place of beginning.
