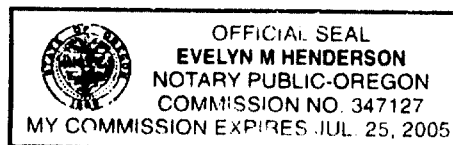

The SE 1/4 NE 1/4 of Section 16, Township 23 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at an iron pin on the East line of Kurtz Road, said point being South 88° 13' 49" West a distance of 1289.54 feet and North 00° 13' 32" East a distance of 983.18 feet from the East one Fourth corner of said Section 16; thence North 00° 13' 32" East along the East line of Kurtz Road a distance of 265.84 feet to an iron pin on the South line of Reeve Road; thence North 86° 50' 15" East along the South line of Reeve Road a distance of 601.00 feet to an iron pin; thence South a distance of 299.00 feet to an iron pin; thence West a distance of 601.14 feet to the point of beginning.
