## KS7/07 TRUSTEE'S DEED

THIS INDENTURE, made this 13th day of June, 2002, between Northwest Trustee Services, LLC, hereinafter called the Trustee and Cendant Mortgage Corporation, hereinafter called the second party;

## **RECITALS:**

RECITALS: Harry M. Lindberg, unmarried man, as grantors, executed and delivered to: Aspen Title and Escrow Inc., as trustee, for the benefit of National Funding Service, Inc., a Oregon corporation, as beneficiary, a trust deed dated 01/12/00, duly recorded on 01/27/00 in the mortgage records of Klamath County, Oregon in Vol M00, Page 2807 and subsequently assigned to Cendant Mortgage Corporation, d.b.a. Further, the trustee published a copy of the Trustee's Notice of Sale in a newspaper of general circulation in each county in which the Property is located, once a week for four successive weeks; the last publication of Notice of Trustee's Sale occurred more than twenty days prior to the date of sale.
