QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Jeffrey K. Hagy hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, Sate of Oregon, described as follows, to-wit:

That portion of Lot 2, Block 17 situated South and West of a point S 01° 36' 38" W 900 feet and East 425.30 feet from the Northwest corner of said Lot 2, Block 17, Klamath Falls Forest Estates Sycan Unit, also described as Lot 2D, Block 17, Klamath Falls Forest Estates Sycan Unit, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

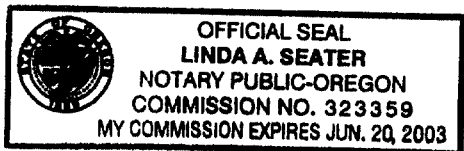
