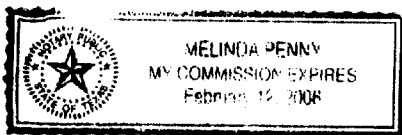




## RECONVEYANCE
