

MEMORANDUM OF LAND SALE AGREEMENT

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$5,220.00, all deferred payments bear interest at the rate of 10% per annum from the date of said Land Sale Agreement until paid.

In Witness Whereof the said vendor has executed this Memorandum June 28, 2002.

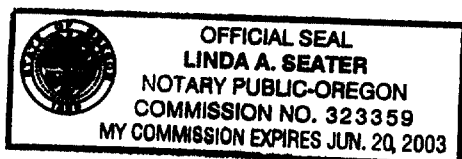
