DESCRIPTION

The following described real property situate in Klamath County, Oregon:

Lots 1, 2, 3, 4 and 5 in Block 4 of The Terraces, an Addition to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

TOGETHER with the Easterly half of vacated Mesa Street and adjacent thereto.

TOGETHER with the portion of the Westerly half of vacated Mesa Street, more particularly described as follows: Beginning at an iron pin at the intersection of the centerline of vacated Mesa Street and the South line, extended, of Lot 5 Block 4 of The Terraces, which said pin is at the point on said centerline from which the Southwest corner of said Lot 5 bears South 89°23'55" East 21.53 feet distance; thence North 89°23'55" West along the South line of said Lot 5, as extended, 19.0 feet to an iron pin; thence North 18°43' West along an existing fence 73.8 feet to a point; thence South 89°21'50" East 15.8 feet to an iron pin on the centerline of vacated Mesa Street; thence South 21°01'40" East along the centerline of vacated Mesa Street 74.9 feet, more or less, to the point of beginning.
