Within Tract 1034, Lakewoods Subdivision Unit No. 1; Tract 1051, Lakewoods Subdivision Unit No. 2; Tract 1077, Lakewoods Subdivision Unit No. 3; located in Gov't. Lots 1,2 & 3, Sect. 5, T-38-S, R-5-E.W.M.
