MODIFICATION OF DEED OF TRUST

Term loan out from line of credit, principal increase to \$400,000.00 to cross collateralize Promissory Notes #830125581 and #830403987 and extend Maturity Date to June 30, 2012.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect.
