**FIRST AMENDMENT TO DEED OF TRUST**

The line of credit instrument, deed of trust, security agreement, assignment of leases and rents, and fixture filing described below ("Deed of Trust") encumbering certain real property in Klamath County, Oregon, is hereby amended as set forth herein:

Grantor: Red Lion Hotels, Inc., a Delaware corporation

Trustee: U.S. Bank Trust Company, National Association

Beneficiary: U.S. Bank National Association, as administrative agent for the several financial institutions from time to time party to that certain amended and restated credit agreement dated as of December 29, 1999 (together with all amendments, modifications, supplements and exhibits thereto, the "Credit Agreement").

Tax Account Nos.: 3909-003DB-00500-000, 3909-003DB-00600-000.

1. The Deed of Trust is hereby amended to reflect that (a) the Credit Agreement, the guaranty of which is secured by the Deed of Trust, has been amended by that certain fourth amendment to amended and restated credit agreement of even date herewith, (b) the maturity date of the promissory note or notes, the guaranty of which is secured by the Deed of Trust, has been extended to June 30, 2002, exclusive of any option to renew or extend such maturity date, and (c) the maximum aggregate principal amount to be outstanding at any one time pursuant to the Credit Agreement, the guaranty of which is secured by the Deed of Trust, has been reduced to \$68,500,000.


2. Except as specifically provided for herein, all of the terms and conditions of the Deed of Trust shall remain in full force and effect.

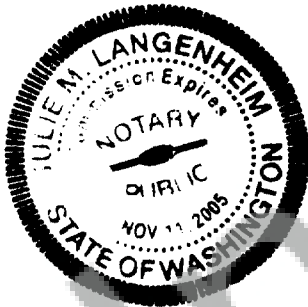

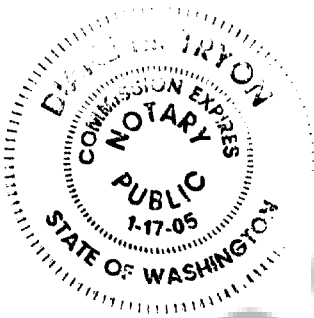
